

Dear Mr Gubbins,

Given that there has been a huge amount of time passed since this application was last discussed in any detail, are you able to give an update as to where the application has got to from your departments perspective, and what the next stages are? We are unfortunately rather in the dark as far as the process being undertaken by Peter Scott is concerned (on behalf of the applicants), and we continue to feel that we are neither being 'heard', nor are we gaining 'fair representation' by the rather one sided Several Order application mechanism.

To remind, right at the beginning of this challenging process, our MP (Bernard Jenkin) had to step in at my request to help prevent this application from being cynically 'slipped through' before anyone had heard about it. Only after Bernard Jenkins 'gentlemanly pressure' directly to Mr George Ustace MP did we achieve the first consultation, which although very flawed, was still something that was our right to be part of in the first place.

That backdrop sums up the total lack of trust that now exists between the parties. Include the fact that no one in the vicinity supports the development in the first place, and that we are still being fed mis-information between the formal demands of the Several Order, and the informal comments being made to pacify the objectors, and we are effectively no further forward. There remain a swathe of unaddressed queries, an inadequate documentation audit trail which is not fit for purpose, and muddled, if not intentionally confusing, responses.

Whilst I personally think we need the help of our MP once again (to which end this is copied to Bernard Jenkin and Thomas Fairweather) I am interested in your comments and opinion before we embark on that route again. Finally, is the MP with overall departmental responsibility still Mr George Eustace, or has the political landscape completely changed during the last year?

Although there have been some improvements in the proposal, from our point of view. The fact that they are not going to be written into the several order is utterly unacceptable. If there is no record of any agreements then as far as I am concerned no agreements exist. we proceed on the basis that our concerns have not been addressed.

Regarding the alterations to the proposed sites I have asked for latitude and longitude for each because the plans have been based on Ordnance Survey maps and therefore OS co-ordinates, it is not a simple task to transfer them accurately to a nautical chart for comparison and consideration.

1. Two of the most contentious areas have not been removed as he suggests in his recent e:mail to you, Two of them appear from the plans to have been have been slightly reduced. (Areas 1 & 4) .
2. He is not proposing to share an outline of the monitoring programme that has been agreed in principle with Natural England until when and if the Order comes into effect.
3. He is not proposing to carry out another consultation on the revised proposals unless instructed by the Minister.
